#### **BYLAW NO. 2021-07**

# A BYLAW OF THE VILLAGE OF CHAPLIN TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

THE COUNCIL of the Village of Chaplin, in the Province of Saskatchewan, enacts as follows:

- 1. The charges to be paid by the water consumer whose water service whose water service has been turned on shall be those set out in Schedule "A" attached, provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
- 2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services, a rental rate of service charge in accordance with Schedule "B" attached.
- 3. Every customer shall pay a water and sewer infrastructure fee set forth in Schedule "C" attached hereto.
- 4. Accounts for water service and/or sewer service shall cover a period of one month, and shall be rendered on or about the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of one-hundred dollars (\$100.00) to cover the expenses of turning off the water and turning it on again, provided that if it is required to turn on the water service outside of the employees' regular working hours, the fee shall be one-hundred, fifty dollars (\$150.00). Accounts which are outstanding after that year end shall have arrears balance transferred to the taxes of the property where the service is delivered.
- 5. All residents who are owners of a residence shall be required to pay a water deposit of \$100.00 before their water will be connected. All residents who are renters of a residence shall be required to pay a water deposit of \$200.00 before their water will be connected.
- 6. Water surplus shall be set aside into a reserve fund to upgrade water facilities. This shall be done at the end of the fiscal year.
- 7. A penalty of 2.5% shall be added to all water and sewer accounts outstanding at the date of the next billing.
- 8. Bylaw 2020-05 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee

#### SCHEDULE "A" TO BYLAW 2021-07

#### **MONTHLY WATER RATES**

1. All meter locations shall pay the minimum monthly rates set out below:

3,000 gallons or less Minimum \$70.00

2. For consumption in the excess of the minimum amount the rate shall be:

3,001 gallons to 6,000 gallons \$5.00 per 1,000 gallons or part of (inclusive)

6,001 gallons to 9,000 gallons \$5.50 per 1,000 gallons or part of (inclusive)

9,001 gallons to 9,999,999 gallons \$6.00 per 1,000 gallons or part of (inclusive)

3. Unmetered locations shall pay a flat rate of \$70.00 monthly.
